Hi Zoltan.

here are some things to take into account:

- 1. Don't expect the documentation to be helpful
- 2. Always remember 1
- 3. Make sure that you at least use WAS 5.1.1.7
- 4. Make sure you install the WAS integrated messaging option and that you have a JMS Server configuration item after the WAS installation
- Unlike BEA WebLogic, when running a cluster you needs different binaries (WebSphere Application Server Network Deployment / Deployment Manager) than for the standalone solution.
- Make sure you have the latest SI 4.01 connectors from ftp://horta.rose.hp.com/pub/concero/
- 7. The JDBC connection created by the installer will always throw a warning message and be complaining about "SetBigStringTryClob" If you need to get rid of this, I have a separate e-mail describing the required step.
- The Oracle driver might fill your java log with lots of error messages. The reason is that SI uses the Oracle XA driver and you first have to enable XA on the Oracle database.

Get rid of the errors part 1: some Oracle actions for XA support: http://www-1.ibm.com/support/docview.wss?uid=swg21215890

Get rid of the errors part 2:

Oracle requires services such as the WebSphere Application Server transaction service to have special permissions for performing transaction recoveries.

Solution

As user SYS, run the following commands on your Oracle server: grant select on pending_trans\$ to public; grant select on dba_2pc_pending to public; grant select on dba_pending_transactions to public; grant execute on dbms_system to < user>;

This problem is mentioned under Oracle bug: 3979190. Running the preceding commands solves the problem.

- 9. Use the JCE files from Sun and not the ones from IBM (as indicated by the install doc)
- 10. When running a cluster, don't install the JCE files on the Deployment Manager. For some strange reasons you will then not be able to deploy any connectors.
- 11. When deploying in a cluster, deploy to the application node and not to the management node
- 12. When deploying in a cluster, I was told that SI isn't properly assigned

manually after the installation.
13. When installing on HP-UX, you need to run the installer with root or
   at least need to have write privileges to the deployment manager
   directory.
Hope this helps avoiding some of the problems we were experiencing with IBM looking over our shoulders.
